CHWP101D: Introduction to HIPAA for Dental Professionals

#### CHWP101: HIPAA Basics

This lesson provides an overview of the Health Insurance Portability and Accountability Act (HIPAA). It defines key terms, including Protected Health Information (PHI), Covered Entities, and Business Associates. It also describes HIPAA penalties and enforcement.

#### CHWP102: The HIPAA Privacy Rule

This lesson describes the Privacy Rule, the section of HIPAA that protects patient health information. The lesson explains the requirements of patient disclosure of information, the "minimum necessary" principle, and the requirement that medical practices provide patients with a Notice of Privacy Practices (NPP).

#### CHWP103: The HIPAA Security Rule

This lesson describes the Security Rule, the section of HIPAA that specifies safeguards for the protection of patient information, especially PHI in electronic form. These standards are made up of Technical, Physical, and Administrative safeguards. These safeguards are designed to ensure the Confidentiality, Integrity, and Availability (CIA) of patient data.

# CHWP104: Business Associate Regulations

This lesson provides a brief overview of the HIPAA regulations for Business Associates, including who qualifies as a Business Associate. It also describes the requirement that all Business Associates sign agreements with Covered Entities and with their own subcontractors.

### CHWP105: HIPAA Documentation and Training

This lesson describes the requirements for HIPAA-compliant policies and procedures, with guidance on how these should be formulated. It also explains that all personnel who come into contact with PHI must complete HIPAA training on at least an annual basis, and it outlines the requirements for HIPAA awareness programs.

# CHWP106: Applied HIPAA Security for Healthcare Professionals

This lesson addresses frequently asked questions about HIPAA security in the workplace, including best practices for email, hardware integrity, and more.
